

Newsletter Regulations

§1

definitions

For the purposes of these Regulations, the following definitions are adopted:

Regulations - this document specifying the terms and conditions of using the website,

Nire - Nire Sp. z o.o. with its registered office in Cologne Mrokowska, ul. Rejonowa 29, 05-552

Kolonia Mrokowska operating on the basis of an entry in the National Court Register kept by the

District Court in Białystok, 12th Commercial Department of the National Court Register under

number 0000759377, NIP 8442364341, seller and owner of the website www.nire.eu,

Newsletter - an electronic letter sent by Nire to the Customer as part of the Service provided and on the principles set out in the Regulations,

Service - a service that is provided by Nire to the Customer on the terms set out in the Regulations, consisting of sending information in the form of Newsletter (electronic letters) by Nire by e-mail to the e-mail address that will be provided in the registration form by the Customer,

Service Recipient - a natural person, legal person or organizational unit without legal personality who, pursuant to the principles set out in § 4 of these Regulations, has placed an order for the Service with Nire.

§2

1. The service will be provided to the Customer from the date of registering his e-mail address, subject to § 5 of the Regulations.

2. Nire provides the Service free of charge and stipulates that any fees that will be charged independently of Nire, by operators or other persons in connection with the Service Receiver receiving the Newsletter or using internet services shall be borne by the Service Recipient.

3. The Newsletter contains Nire data, information about Nire products, current promotions, events organized by Nire and other news about Nire and a link enabling the Customer to resign from the

Service at any time.

4. Nire sends the Newsletter to the Customer not more often than once a calendar week.

§3

The Customer must meet the following conditions for Nire to provide the Service:

1. possess any electronic device, e.g. a computer, tablet, smartphone, which has a web browser and / or an e-mail program with Internet access,
2. have an active e-mail account,
3. place an order for the Service as described in § 4 of the Regulations.

§4

The Customer to place an order for the Service must do the following on the website www.nire.eu:

1. provide the e-mail address in the registration form,
2. agree to be sent electronically to the e-mail address provided by the Customer in the Newsletter registration form, under the conditions set out in the Regulations,
3. agree to the processing of personal data by Nire and entrusting a third party with the processing of such data only for the purpose of carrying out technical activities related to the sending of the Newsletter,
4. confirm the order for the Newsletter service by clicking the activation link placed in the electronic list provided by the registration system to the e-mail address provided by the Customer in the registration form, the e-mail address registered by the Customer will be used only to provide the Service,
5. After confirming the order in accordance with the provisions of § 4 of the Regulations, the e-mail address provided by the Customer in the registration form will be automatically registered on the list of e-mail addresses of the Service,
6. the date of confirmation of the order, the date of conclusion of the Service User Agreement with Nire for the free provision of the Service in accordance with the Regulations.

§5

1. Nire is the administrator of the Customer's personal data provided for the purpose of providing the Service, in accordance with § 4 of the Regulations.
2. Nire may entrust to a third party, based on a separate written agreement, the processing of personal data provided by the Service Recipient only for the purpose of carrying out technical activities related to the sending of the Newsletter.
3. The Customer's personal data processed on the basis of the consent given by the Customer.
4. The Customer may request from Nire access to his personal data, rectification, deletion, limitation of processing or the right to object to their processing, and also has the right to transfer data. The recipient has the right to withdraw consent at any time and the right to lodge a complaint to the supervisory authority.

§ 6

1. The Service Recipient has the right to resign from the Service without giving a reason and without incurring costs. The resignation will occur by clicking on the resignation link placed at the bottom of each Newsletter sent by the Customer.
2. When the Customer withdraws, the e-mail address indicated in the registration form is removed from the list of e-mail addresses of the Service.
3. Submission of a resignation is tantamount to the termination of the Agreement referred to in § 4 of the Regulations.

§ 7

1. The Customer may not provide or transfer any content that is not in accordance with generally applicable law in Poland.
2. Nire may cease to provide the Service to a Service User who does not comply with the Regulations and / or generally applicable law in Poland or undertakes actions interfering with the effective and correct use of the Service by him and other service recipients.

§8

1. Complaints related to the Service, the Customer may be submitted:
 - electronic to the following address: biuro@nire.eu
 - in person or in writing to the address of the seat of Nire given in § 10 below,
2. The complaint must contain at least: the e-mail address provided by the Customer in the registration form when placing the order for the Service, a description of the subject of the

complaint and the e-mail address to which Nire will send a response to the complaint, if the Customer wishes to receive a response to a complaint via e-mail to an e-mail address other than the e-mail address provided when ordering the Service.

3. Nire will consider the complaint immediately, not later than within 14 days from the date of receipt of the complaint by Nire and inform the Client about the decision regarding his complaint.

4. In the event of formal deficiencies which make it impossible to consider the complaint, Nire will ask the Customer to fill in the deficiencies at the e-mail address provided in the complaint.

§ 9

1. Nire has the right to amend the Regulations.

2. The Service Recipient will be notified of any changes to the Regulations by sending a Newsletter with information about the change.

3. The amendment to the Regulations will be effective from the date given in the notification, but not earlier than after 14 calendar days from the date of sending the Newsletter to the Client.

4. The amendment to the Regulations will apply to the Service Recipient if, within the time limit referred to in § 9 paragraph 3 above, the Service Recipient fails to submit a declaration of resignation from the Service.

5. In the situation referred to in § 9 para. 4 above, the Service Recipient has the right to resign from the Service in the manner described in § 6 of these Regulations and submitting his resignation is tantamount to the termination of the Agreement referred to in § 4 of these Regulations.
